### CONDITIONS FOR BOAT STORAGE

Boat storage is allocated to registered boats on the basis that the member's intended use of the stored boat is for **participation in Club sailing events. The Club will seek the removal of the boat in the event that it fails to compete in 6 consecutive races, if written approval has not been sought from the club committee.** The owner will remove the boat within 21 days of receipt of a written request from the Club committee. Failure to do so will imply that the club may dispose of the stored boat in any manner deemed appropriate by the Club committee. Boat storage **is not** transferable.

### RISK WARNING

This Risk Warning is issued jointly by A12SC to all persons wishing to store their boats at the A12SC Clubhouse. Boat owners are warned that, regardless of any precautions which may be taken by reasonable and experienced persons, boat storage at A12SC is subject to risks which may include, but are not limited to -: fire, vandalism, theft, wind or wave damage, structural failure of the A12SC Clubhouse. Boat owners are advised that although A12SC is covered by property insurance, this **DOES NOT** extend to boats stored in the A12SC Clubhouse. Any boat owner who considers they have a need for insurance for their boat must make private arrangements with an insurer.

### LIABILITY

Each boat owner acknowledges that he or she

- Has read the Risk Warning and the exclusion from liability provision contained in the Sailing Instructions.
- Stores his or her boat in the A12SC Clubhouse at their own risk and responsibility
- Excludes A12SC from all liability, including but not limited to liability for negligence
- Accepts that A12SC is not responsible for the safety or protection of any boat stored at A12SC, and
- Indemnifies A12SC for all claims arising from total or partial loss of his/her boat while stored at A12SC
